## Whatever Club Promotion Official Rules and Regulations

**The promotion ends September 30th, 2025.**

**Prizes will be awarded by 10/29/2025**

### **Sweepstakes Summary:**

Belco Community Credit Union will conduct a Sweepstakes promotion where members will open a new Whatever Club Account. Beginning 09/01/2025 and ending on 09/30/2025 (the "Sweepstakes Period"), individuals who are members of Credit Union (defined below) and are 18 years of age or older, and who opens a Whatever Club account along with their Belco Community Credit Union Account will be automatically entered into a random drawing for a chance to win the prizes described in Sections 5 and 6 of these Official Rules. Details regarding Sweepstakes terms and conditions, including an alternative entry method and certain limitations regarding the number of entries that will be allowed, are found below. The Sweepstakes winner will be determined by random drawing from all eligible entries received by the methods of entry that are described in these Official Rules. The odds of winning the Sweepstakes, which will not vary based on the method of entry, are dependent on the number of eligible entries that are received by both methods of entry. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. VOID WHERE PROHIBITED BY LAW. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. 1. **Eligibility Restrictions:** Promotion is open to anyone who is 18 years of age and older, and within the Belco Community Credit Union field of membership. (Field of Membership: Persons who live, work, worship, attend school, or volunteer in the Pennsylvania counties of York, Adams, Dauphin, Perry, Cumberland, Lancaster, Lebanon.) Employees of Belco Community Credit Union, Board of Directors, officials, immediate family members, and participating sponsors/promotional partners are not eligible. Business accounts are not eligible. Cannot be combined with other offers. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.
2. **Promotion period:** The Promotion begins at 12 a.m. Eastern Standard Time ("EST") on 09/01/2025 and ends at 11:59 p.m. EST on 09/30/2025 (the "Promotion Period").
3. **Sponsor:** The Sponsor of this Promotion is Belco Community Credit Union Credit Union, 449 Eisenhower Blvd, Harrisburg PA, 17111.
4. **How to Enter:**  
**There are two (2) ways to enter.**
  - a. Open a new Whatever Club account with Belco Community Credit Union. Opening a Whatever Club means you add a Whatever Club Account onto your existing or new Belco Community Credit Union account. When the new Whatever Club account is opened with Belco Community Credit Union account between 09/01/2025 and 09/30/2025, you, the member will be entered to win. There is a limit of one new Whatever Club per account for this promotion if the new member opens a Belco Community Credit Union Whatever Club account between 09/01/2025 and 09/30/2025. Only one account per new member is allowed.

- b. Send a postcard with your name, address, and phone number to: Belco Community Credit Union Credit Union, Attn: Marketing Department, Whatever Club Promotion, 449 Eisenhower Blvd, Harrisburg PA, 17111. Valid entries must be postmarked no later than the end of the month and received by the 5<sup>th</sup> of the following month. Mailed entries will not be acknowledged or returned. Participants must provide all the contact information requested, or the entry will be void. Belco Community Credit Union is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected, or postage due mailed entries, which will be disqualified. Any attempt by an Entrant to obtain more than one entry by using fraudulent, deceptive, or illegal means will be disqualified. Automated mail entries, or those made using script, macro, sweepstakes service, automated entry software, or facsimiles will NOT be accepted.
5. **Prizes, Prize Conditions, and Odds: 5 separate winners will be randomly selected to win a \$75 dollar gift card to Sheetz®.** No substitution or transfer of prizes is permitted except at Sponsor's sole discretion. Prizes must be accepted as awarded. If a prize, or any portion thereof, cannot be awarded for any reason, Sponsor reserves the right to substitute a prize of equal or greater value. All federal, state and local taxes, and all other costs associated with acceptance or use of the prizes, are the sole responsibility of the winner. Arrangements for delivery of prizes will be performed after winner validation. Odds of winning any prize depend on the number of entries received. If winner cannot be contacted or has not claimed the prize by 11/01/2025, an alternate winner will be randomly selected from all remaining entries. Prizes will be retrieved by the winner at any Belco branch. No substitution or transfer of prizes is permitted except at Sponsor's sole discretion. Prizes must be accepted as awarded. If a prize, or any portion thereof, cannot be awarded for any reason, Sponsor reserves the right to substitute a prize of equal or greater value. All federal, state and local taxes, and all other costs associated with acceptance or use of the prizes, are the sole responsibility of the winner. RELEASED PARTIES BE RESPONSIBLE OR LIABLE FOR ANY DAMAGES OR LOSSES OF ANY KIND (INCLUDING WITHOUT LIMITATION, DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES) ARISING OUT OF PARTICIPATION IN THIS CONTEST OR THE ACCEPTANCE, POSSESSION, USE, OR MISUSE OF, OR ANY HARM RESULTING FROM THE ACCEPTANCE, POSSESSION, USE OR MISUSE OF THE PRIZE. Participants further agree that Released Parties' liability will be limited to the cost of entering and participating in the Promotion, and in no event shall the Released Parties be liable for attorney's fees. Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

9. **General Conditions:** Belco Community Credit Union reserves the right to cancel, suspend, and/or modify the Promotion or any part of it, for any reason, including if any fraud, technical failures, human error, or any other factor impairs the integrity or proper functioning of the Promotion, as determined by Sponsor in its sole discretion. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should such an attempt be made, Sponsor reserves the right to seek damage from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
10. **Limitations of Liability:** Belco Community Credit Union officers, directors, employees, agents, and representatives are not responsible for typographical or other errors in the printing, stolen, lost, late, garbled, delayed, misdirected, damaged, incomplete, postage due, or ineligible entries or in the offering or the administration of the contest or in the announcement of the prize. If, in the exclusive judgment of Belco Community Credit Union, this contest becomes compromised in any way, Belco Community Credit Union reserves the right to withdraw the contest offer, cancel any method of entry, void any entries submitted fraudulently, or select winners from all eligible entries received prior to the act that compromised the contest. By entering, entrants acknowledge compliance with these Official Rules including all eligibility requirements.
11. **Disputes:** Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Promotion or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by a state or federal court located in Pennsylvania; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these official rules, or the rights and obligations of the entrant and Main Sponsor in connection with the Promotion, shall be governed by, and construed in accordance with, the laws of the Commonwealth of Pennsylvania, without giving effect to any choice of law or conflict of law rules (whether of the Commonwealth of Pennsylvania or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the Commonwealth of Pennsylvania.
